3. Miscellaneous petitions, if any, pending in this Writ Petition shall stand closed. There shall be no order as to costs.

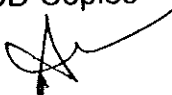

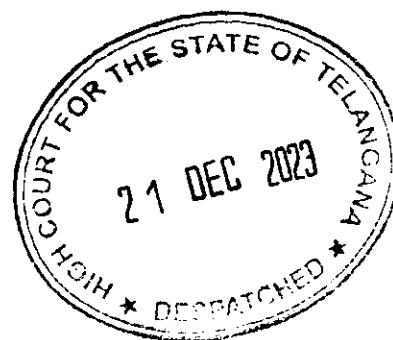
