This Criminal Petition under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.'), is filed seeking by the petitioner-accused to quash the proceedings in C.C.No.247 of 2013 on the file of IV Additional Judicial Magistrate of First Class at Warangal, registered for the offence 138 of Negotiable Instrument Act, 1881.

2. None appears for the petitioner-accused. The criminal petition was filed in the year 2016. No interim orders were passed. The several questions of fact are raised in the ground of petition filed. 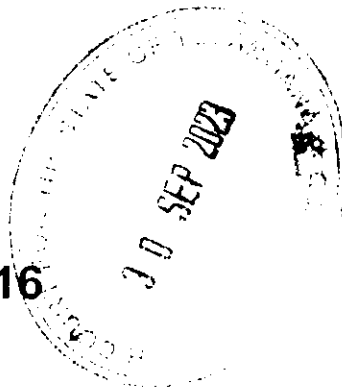
