Sri K.Sanjeev, learned counsel appearing for respondents submitted that the respondents have complied with the order passed by this Court, nothing remains in this contempt case and there is no intent for non compliance can be attributed to the respondents. Hence seeks to close this contempt case.

Sri Prasad Rao, learned counsel representing Ms. A.Padma, learned counsel for the petitioner submitted that the proceedings issued by the respondents *vide* No.Admn/SE/CC/BSM/N-1491, dated 05.12.2023 has to be examined in detail and if necessary to take further course of action with the permission of this Court.

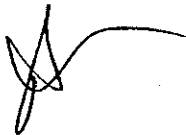

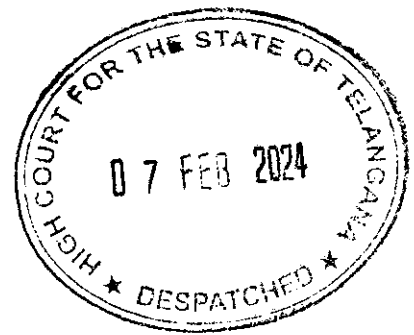
