Today when the matter has been taken up for hearing, learned counsel for the petitioner submits that the then Andhra Pradesh Administrative Tribunal, Hyderabad by order dated 24.02.2014, passed interim order as follows:-

"Pending disposal of the O.A., the impugned Charge Memo.No.2709/DC/C4/AC(A)OP3/GHMC/2014-28 dated 29.01.2014 is suspended with a direction to the respondents to consider the case of the applicant for promotion to the post of Assistant City Planner and his promotion is subject to out come of the OA."
