Mandamus, declaring the impugned proceedings bearing Lr. No. 119/SDF/Plg-II/2021-22-DVK, dated- 22-08-2022 issued by the District Collector, Nalgonda, as arbitrary, contrary to the spirit of G.O. Rt. No. 232 Planning (VI) Department dt. 11/06/2021, in violation of Chapter-III Section 11 (a), (b), (c) of Telangana State Scheduled Castes and Scheduled Tribes Special, Development Fund (Planning, Allocation and Utilization of Financial Resources) Act 2017, contrary to the resolutions dated- 22/06/2021 passed by the 10th Respondent Gampanmchayat, illegal and void and consequently set aside the same by directing the Respondents to allot the Special Development Funds under the G.O. Rt. No. 232 dt. 11/06/2021 for Welfare and Development Activities for road works in the Chintapally Gramapanchayat, Nalgonda District, as per the resolutions dated- 22/06/2022 passed by the Chintapally Gramapanchayat and in accordance with the provisions of the Chapter-III Section 11 (a), (b), (c) of Telangana State Scheduled Castes and Scheduled Tribes Special Development Fund (Planning, Allocation and Utilization of Financial Resources) Act 2017.
