Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of writ of Mandamus declaring the action of the respondents 1&2 rejecting the pleas of the Writ Petitioner for apportionment of compensation of acquiring the land of the petitioner for outer Ring Road Project(ORRP) an extent of 1-00 acre in Sy.No.166 at Dayara (V) Keesara(M) R.R District as arbitrary and against the principles of natural justice and consequently direct the respondent No.1 to pay the compensation amount to the land acquired on par with the other lands at Dayara(V) Keesara(M) R.R District.

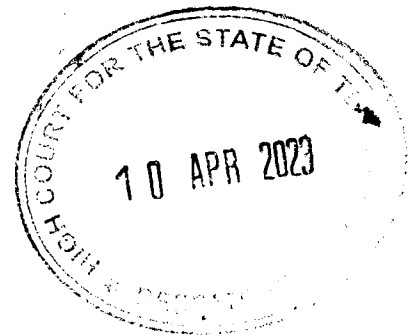
