Pending Miscellaneous applications, if any, shall stand closed.

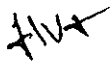

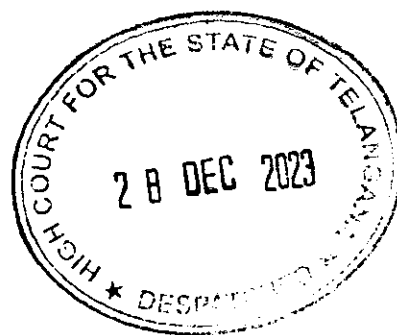
