No.6 to an extent of 307 Sq. Yards(old), situated at Sy.533, new Sy.No. 533/A of Bheemaram Village, Hasanparthy Mandal, Warangal Urban District as illegal, arbitrary and null and void and violation of the Section 450 of Greater Hyderabad Municipal Corporation Act and consequently direct the respondents to take appropriate action against the respondents in restraining the unofficial respondents in proceeding with the construction.

Yards(old), situated at Sy.533, new Sy.No. 533/A of Bheemaram Village, Hasanparthy Mandal, Warangal Urban District, pending disposal of the Writ Petition.
