Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of writ of mandamus or any other appropriate writ declaring the action of the respondent no.2 in threatening to demolish construction made by the petitioner for his residential house in plot of land admeasuring 0.02 guntas in plot No. 1005/1 of Kusthapur village of Mallapur Mandal, Karimnagar District and also threatening that, the petitioner shall not proceed with the construction in the said plot of his land, even though the petitioner is proceeding with the construction under the deemed permission as already the petitioner submitted his application requesting

to grant permission on 10-10-2013, is nothing but arbitrary, illegal, null and void and also violative of principles of natural justice and also violative of Articles 14, 19, 21 and 300-A of the Constitution of India.
