Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate writ order or direction particularly one in the nature of writ of mandamus declaring the action of the respondents in not considering the case of the petitioner and not appointing the petitioner as Sub Engineer against resultant vacancies of non-joining relinquishment of selected candidates by within the validity period of waiting list pursuant to the notification No. 3/ 2010, dt. 03.10.2010 issued by the 2nd respondent as arbitrary, illegal and violative of Articles 14,16 and 21 of the Constitution of India and consequently direct the respondents to consider the petitioners case for appointment as Sub-Engineer under Nalgonda District local candidates quota based on his merit in the written test by operating the waiting list, pursuant to the notification No. 3/2010 dt. 03.10.2010 issued by the 2nd respondent and appoint the petitioner as Sub-Engineer against the existing vacancies, by considering the petitioners representation dated 18.10.2011.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the petitioner's case for appointment as Sub-Engineer under Nalgonda District local candidates quota based on his merit in the written test by operating the waiting list pursuant to the Notification No. 3/2010 dt. 03.10.2010 issued by the 2nd respondent and appoint the petitioner as Sub-Engineer against the existing vacancies, by considering the petitioner's representation dated 18.10.2011, pending the above writ petition.

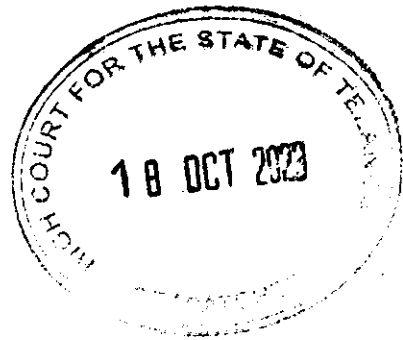
