the building permit dated 20-06-2022, without vide File No.006560/GHMC/3272/SLP2/2022BP of the petitioner in respect of Plot No.103 Type-A, in Survey No.73, total admeasuring 443.00 Sq.yds., situated at Block No.1 Kondapur (V), Serilingampally (M), Ranga Reddy District, and bounded by North. 40 feet Wide Road, South. Plot No.102, East. Plot No.84, West. 40 feet Wide Road, without insisting to leave 60 feet set back on side Plot No.84.

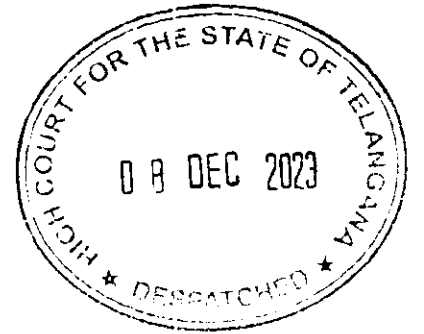
