J U D G M E N T:

This appeal suit is filed against the Judgment and Decree dated 31.12.2008 in O.S.No.629 of 2006, passed by the learned VIII - Additional Senior Civil Judge, Rangareddy District at L.B.Nagar.

2. The appellant herein filed a suit *vide* O.S.No.629 of 2006 against the respondent for compensation of Rs.10,00,000/- and the same was dismissed by the trial Court. Aggrieved by the said Judgment, preferred the second appeal.

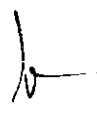
