ORDER:

As the respondent No.1 has not complied with the orders passed by this Court, the present contempt case has been filed. Even after completion of ten (10) years, no counter is filed by the respondents and the learned counsel for the petitioner is unable to get instructions whether the cause in the contempt case survives or not.

2. Recording the aforementioned submission, this contempt case is closed. There shall be no order as to costs.

3. Miscellaneous petitions, if any, pending shall stand closed.

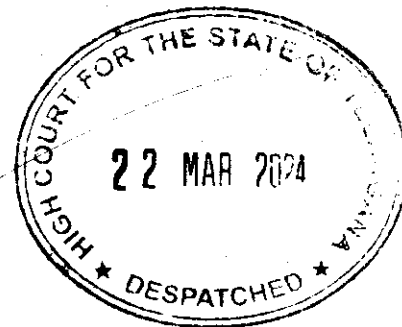
