As a sequel, pending Miscellaneous Applications, if any, shall stand closed.

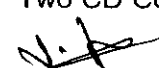

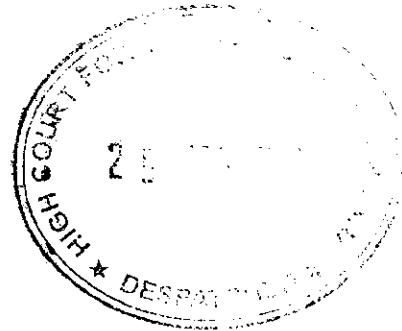
