ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners/Accused Nos.2, 3 and 4 seeking to quash the proceedings against them in C.C.No.9617 of 2022 pending on the file of learned IX Additional Metropolitan Magistrate at Kukatpally, Cyberabad, registered for the offence under Section 498-A of Indian Penal Code.

2. Heard Sri M. Amarnath, learned counsel for the petitioners, Sri S. Ganesh, learned Assistant Public Prosecutor for the respondent No.1-State. Perused the record.

3. It is submitted that the C.C. is coming up for trial and the petitioners are the father-in-law, mother-in-law and brother-in-law respectively of respondent No.2.

4. Taking into consideration the fact that a false case is registered against the petitioners/A2, A3 and A4 and the allegations levelled against them are false and baseless, the Criminal Petition is disposed of and the appearance/attendance of the petitioners/A2, A3 and A4 before the learned IX Additional Metropolitan Magistrate at Kukatpally, Cyberabad, is dispensed with unless and until their presence is required by the trial Court for giving evidence/for a specific purpose.

Miscellaneous applications, if any pending, shall stand closed.

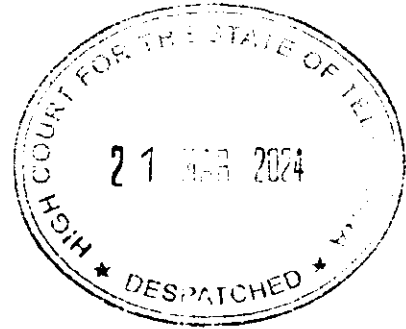
