Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or Orders more in the nature of the Writ of Mandamus declaring the action of the respondents in not considering the petitioners appeal dt.12.01.2022 to transfer Hyderabad District under spouse category from Lecturer in Chemistry at BRR Govt. Degree College, Jadcherla, Mahabubnagar District on par with the other applicants who were transfer as G.O.Rt.No.155, higher Education (CE) Department, dt.27.08.2022 is illegal, arbitrary and in violation of Article 21 of the Constitution of India and consequently direct the respondents 1 to 4 to transfer and post the petitioner as Lecturer (Chemistry) in Hyderabad District under spouse category from Lecturer in Chemistry at BRR Govt. Degree College, Jadcherla, Mahabubnagar District on par with the other applicants who were transfer as G.O.Rt.No.155, Higher

Education (CE) Department, dt.27.08.2022 by considering petitioners representation dated - 12.01.2022;
