ORDER:

1. This Criminal Petition is filed under Section 438 of Cr.P.C. by the petitioner/Accused seeking anticipatory bail in the event of his arrest in connection with F.I.R.No.881 of 2023 of Jeedimetla police station on the file of VIII Additional Metropolitan Magistrate, at Medchal, Cyberabad, Medchal District, registered for the offences punishable under Sections 354-D of the Indian Penal Code, 67 ITA Act 2008, 11, 12 POCSO Act 2012.
2. Heard learned counsel for the petitioner and learned Additional Public Prosecutor for the respondent-State and perused the record.
3. On perusal of the record, since the punishment prescribed for the offences alleged against the petitioner is up to seven years, this Court deems it appropriate to direct the Investigating Officer in F.I.R.No.881 of 2023 on the file of the Jeedimetla police station, Medchal District, to follow the procedure laid down under Section 41-A Cr.P.C and also the guidelines formulated by the Hon'ble Supreme Court in ***Arnesh Kumar v. State of Bihar***¹ scrupulously. The petitioner shall co-operate with the

Investigating Officer by furnishing information and documents as sought in concluding the investigation.

4. Accordingly, the Criminal Petition is disposed off. Miscellaneous applications pending, if any, shall stand closed.
