Gazettee Supplemental Part II dated 9.2.1989 as illegal, arbitrary, malafide, without jurisdiction, null and void; and consequently direct the 1st respondent to delete above Gazette Notification.

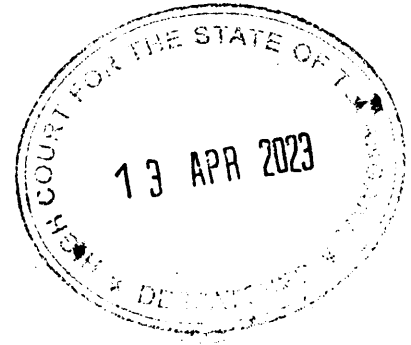
