Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one issue an order or direction more particularly one in the nature of writ of Mandamus declaring the action of the Respondents in not considering my case for promotion to the post of ADC/Controller as per the seniority and denying my promotion by not counting my service from the date of regularization w.e.f 1-7-1987 and promoting my juniors as illegal unjust and arbitrary and as such liable to be set aside in the interest of the justice with a consequential direction to promote the petitioner on par with his batch mates with all consequential benefits.

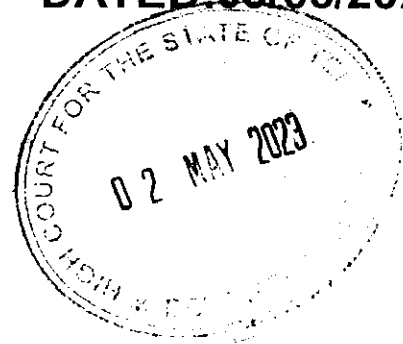
