ORDER:

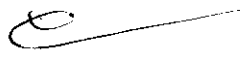

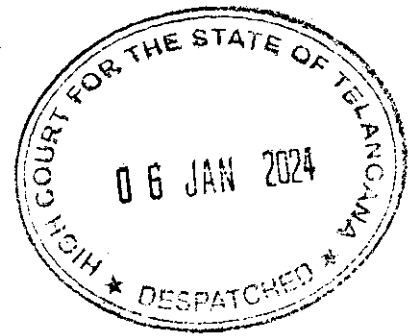
