This criminal petition is filed by petitioners/accused No.1 to 3 to quash the FIR No.403 of 2015 of P.S. Petbasheerabad, Cyberabad, Ranga Reddy District.

Learned counsel for the petitioner fairly submits that the subject matter of the petition does not survive and no further orders are required to be passed in this matter, as the matter was referred as "civil in nature" on 31.10.2015 and hence seeks to close the criminal petition as infructuous.

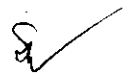

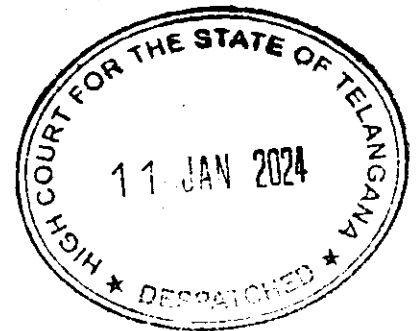
