ORDER:

This criminal petition is filed seeking to call for records in C.C.No.18 of 2011 on the file of Judicial Magistrate of First Class at Yellandu, Khammam District.

2. Learned counsel for the petitioners submits that the cause in the Criminal Petition does not survive for adjudication. Therefore, no further orders are required and hence seeks to dismiss the same as infructuous.
