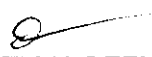
3. In view of the disposal of the main Writ Petition, no further adjudication is required.

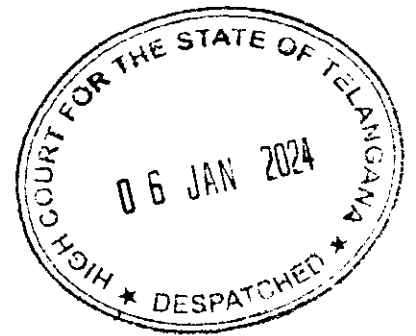
