Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or order or direction more particularly in the nature of writ of mandamus declaring the action of the respondent in not disposing of petitioner representations dated 22.3.2011 and 18.8.2011 as illegal, arbitrary, and violative of the fundamental rights guaranteed to petitioner under Article 14 of the Constitution of India and consequently direct the respondent to make correction in the electricity bills thereby removing the illegally demanded amount of Rs.27,290/-.

I.A. NO: 1 OF 2011(WPMP. NO: 30925 OF 2011)

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent not to disconnect electricity supply to petitioner house under Consumer No.A9021104 thereby allowing her to pay normal electricity bills regularly to the respondent without insisting on payment of Rs.27,290/- pending disposal of the present writ petition.

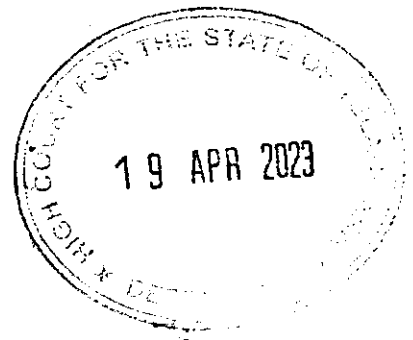
