This Criminal Petition, under Section 482 of the Code of Criminal Procedure, 1973 (Cr.P.C), is filed by the petitioner/accused seeking to quash the proceedings against the petitioner in C.C.No.498 of 2015 on the file of XIV Special Magistrate Court, Erramanzil, Hyderabad. The offences alleged against the petitioner are punishable under Section 138 of Negotiable Instruments Act, 1881 and Section 420 of IPC.

2. None appears for the petitioners.

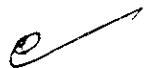
