Prayer made in the present petition was for seeking issuance of directions to respondent-District Registrar to finalize the objections with respect to collegiums and to hold the elections of the Society within a time bound manner as the same was being unnecessarily delayed. Vide order dated 18.05.2023, the District Registrar, Kaithal was called to appear in person. In compliance thereto Sh. Gian Chand, District Registrar, Kaithal is present in the Court. He undertakes that the election to the Jat High School Society, Kaithal shall be positively held within a period of 06 months from today and

In view of the prayer made in the present writ petition, the applicants are not a necessary party to the present petition. The applications are accordingly dismissed. They may, if so advised, take up their issues before the District Registrar in a manner known to law.

In view of the aforesaid statement made today by Sh. Gian Chand, District Registrar, Kaithal, counsel for the petitioner does not press the instant petition at this stage.

Disposed of accordingly.
