By this common order, above mentioned writ petitions, the details of which have been given in heading, are being disposed of.

In these petitions, grievance of the petitioners is that answer key to the questions, which they have attempted, is incorrect and is liable to be revised.

Learned counsel appearing on behalf of the petitioners submit that keeping in view certain observations made by the Expert Committee, the Commission should re-consider as to whether, the answer key should be revised or not and pass an appropriate order. Learned counsel for the petitioners further submits that the petitioners are ready to file appropriate representation supplying the material for consideration of the Commission in this regard.

Learned State counsel submits that in case any representation is filed by the petitioners, the same will be considered in accordance with law and an appropriate speaking order will be passed within a period of eight weeks of the receipt of any such representation and after passing of the order, in case any benefit is to be extended to the petitioners, the same will also be extended to them within a further period of four weeks.

Learned counsel for the petitioners submit that in view of the statement of learned State counsel, the present petitions may kindly be

disposed of having been not pressed with liberty to the petitioners to avail appropriate remedy, in case they are aggrieved by the decision of the Commission on their representation.
