AMAN CHAUDHARY. J.

1. The present petition has been filed under Section 482 Cr.P.C. for issuance of a direction to respondent Nos.2 and 3 to take necessary action in respect of representation dated 30.11.2022 made by the petitioner and initiate necessary and desirable steps against the accused persons.

2. Reply by way of affidavit of Tarun Saini, HPS, DSP, Ladwa Kurukshetra has been filed by learned State counsel. The same is taken on record.

He makes a reference to paras 4 to 6 thereof, which reads thus:-

“4. That during investigation of the present case ASI Kamal Kumar no.833/KKR on 30.11.2022 along with other police official went to Amira Pure Foods Private Limited Patodi Road Village Hasroor District Gurugram Plot and joined the following persons of the locality in the present.

i). Vijay Pal son of Ram Chander resident of Village Harshau, District Gurugram aged 62 years (Local resident).

ii). Dilbag Singh son of Sh. Jai Ram resident of Village Harshau Gurugram (Local residence).

iii). Subash Kumar son of Sh. Krishan Lal resident of Village Bandholi. District Gurugram (Local residence).

iv). Satparkash son of Sh. Rajinder Kumar resident of Bandholi Gurugram (Local residence).

v). Monu Tanwar son of Paramhans resident of Village Harshau Patodi Road Gurugram (in front of Global Signature Car Workshop).

The above named persons have stated that near their village

land so many companies were installed in those companies the peoples residing in village and near the village are doing jobs. In village Harshau in the name of Pure Foods were came but after some time the above said company after left its material there and went from the Village Harshau and it has also came to know that the above said company was declared defaulter by the bank because company has taken loan of crores of rupees and they also stated that they are not knowing above the owner of the above said company. However, the above named persons as well as other persons of the located directed by the police that as and when they came to know about the address of the owner or other employees of the above said company then they will be informed the police of Police Station Ladwa, District Kurukshetra or to inform the local police.

5. Thereafter, the Station House Officer, Police Station Ladwa has given his affidavit in the present case that the police has made best efforts and going on the given address but no clue is found regarding the residence of accused persons of the present case and finally the matter was closed by the police and information regarding to close the investigation also sent to the higher officer on 16.12.2022. The copy of affidavit of Station House Officer, Police Station Ladwa is enclosed herewith as Annexure R-1 for kind perusal of this Hon'ble Court. However, in future any information will be received regarding the correct address of the accused persons of the present case then necessary action will be taken in the present case.

6. That after untrace report dated 16.12.2022 the intimation was also given to the present petitioner regarding the same and after completion of necessary formalities the untrace report was sent to the higher officer for depositing the same before the Hon'ble Court vide R.C. No.1025 dated 16.12.2022.”

3. In view of the above, the present petition has been rendered infructuous and is disposed of accordingly.
