Challenge in the present petition is to the order dated 11.01.2023 (Annexure P-13) passed by the respondents to the extent of posting given to the petitioner.

Learned counsel for the petitioner contends that after having been promoted as a Principal, the petitioner has been transferred to GSSS, Jamalpur, Rewari i.e. 140 km. far away from his home town; that the petitioner, who is suffering from chronic heart disease, submitted his representation claiming therein additional ten marks on MIS Portal, on the basis of the chronic disease certificate, but the same was not considered by the authorities. Learned counsel submits that the petitioner is not claiming any plum posting, rather he may be transferred to the place near his home town as per his entitlement.

I have heard the learned counsel for the petitioner.

Indisputably, the petitioner was appointed as a Lecturer,

School Cadre in Chemistry (now known as PGT) in pursuance of the order dated 17.05.1999. The petitioner has now been promoted to the post of Principal, vide order dated 11.01.2013 (Annexure P-13). The case of the petitioner is that while transferring him, his chronic disease certificate was not considered by the authority.

However in pursuance of his promotion order, the petitioner has not joined till date and has filed the present petition just to get the positing of his choice. Moreover, an employee can be transferred by the Government at any time in cases of administrative exigencies. A perusal of the impugned order dated 11.01.2023 would show that the same is purely initially temporary posting for stop gap arrangement till the next transfer drive and all the officers would have to participate in the Teachers' Transfer Driver for obtaining permanent posting as per their entitlement. It will be very difficult for this Court to interfere into every decision that is taken on the Administrative side

Respondent No.1-Additional Chief Secretary to Government of Haryana, School Education Department, is directed to take into consideration that the employees like the petitioner, who have not joined the duties even on promotion, are approaching this Court for posting of their choice/plum posting.

In view of the above, this Court does not find any merit in the present petition.

Dismissed.
