This is a petition that has been filed under Articles 226/227 of the Constitution of India, seeking issuance of a writ in the nature of mandamus directing respondent No.4 to fix a date to consider the No Confidence Motion against respondent No.5.

In brief, the facts as stated are that the petitioners are Directors of the Kurukshetra Central Cooperative Bank Limited, Kurukshetra and respondent No.5 is the Chairman of Kurukshetra Central Cooperative Bank Limited, Kurukshetra, who has allegedly misused his post and is acting contrary to the interest of the said Bank. Consequent to the actions of respondent No.5, the petitioners submitted an application dated 21.10.2022 (Annexure P-3) to the General Manager, Kurukshetra Central Cooperative Bank Limited, Kurukshetra seeking No Confidence Motion to be passed

against the Chairman of Kurukshetra Central Cooperative Bank Limited, Kurukshetra. The Registrar, Cooperative Societies, Haryana took note of the application given to the General Manager, Kurukshetra Central Cooperative Bank Limited, Kurukshetra regarding the proposal to bring-forth No Confidence Motion against the Chairman, Kurukshetra Central Cooperative Bank Limited, Kurukshetra and directed the Deputy Registrar, Cooperative Societies, Karnal to summon a meeting for consideration of the said No Confidence Motion against the Chairman, Kurukshetra Central Cooperative Bank Limited, Kurukshetra. Since a meeting was not being convened despite Registrar, Cooperative Societies, Haryana instructing the Deputy Registrar, Cooperative Societies, Karnal to do so, the instant writ petition has been filed.

Pursuant to notice of motion having been issued on the limited prayer made in the instant writ petition seeking direction to be issued to respondent No.4 to convene a meeting regarding No Confidence Motion against respondent No.5, this Court is informed by the State counsel that a meeting shall be convened on 09.02.2023. This statement is being made on instructions received from Sh. Rohit Gupta, Deputy Registrar, Cooperative Societies, Karnal himself.

In view of the said statement having been made, learned counsel for the petitioners does not press the instant writ petition and the same is disposed of as such.
