**MAHABIR SINGH SINDHU, J.**

Present petition has been filed under Section 482 Cr.P.C. praying for quashing of FIR No.125 dated 08.07.2021 (P-1), under Sections 406, 420, 120-B of the Indian Penal Code, 1860; Section 24 of the Emigration Act, 1983, registered at Police Station Ghagga, District Patiala along with all consequential proceedings arising therefrom on the basis of compromise dated 02.04.2021 (P-2), entered into between the parties i.e. petitioners as well as respondent No.2.

(2) Above FIR was registered on the basis of statement made by respondent No.2-Mithu Ram with the allegations that petitioners along with other co-accused, in connivance with each other, committed fraud to the tune of Rs.8.7 Lakh on the pretext of releasing the complainant's son from the jail of U.S.A. When accused had not performed their job, complainant asked them to return his money; but they threatened him.

(3) This Court, on 27.07.2023, passed the following order:-

*"Let parties appear before the Court of learned Illaqa Magistrate/trial Court on 11.08.2023 for recording their statement(s) with reference to the compromise, if any, entered into between them.*

*(2) Learned Illaqa Magistrate/trial Court shall record the statement(s) of all accused, complainant/injured and victim, if any, and submit a report to this Court before the next date of hearing containing the following information:-*

*(i). Whether the statements of the parties are bona fide and not result of any pressure or coercion etc. in any manner?*

*(ii). Whether the compromise effected between the parties is genuine and valid?*

*(iii). Whether all the accused, complainant and injured are party to the compromise and if not, the details/particulars of such person(s)?*

*(iv). Whether any other case is pending against either of the parties or not, if yes, the details thereof?*

*(v). Whether any of the persons involved in this case/dispute has been declared a proclaimed offender?*

*(vi). Whether any of the petitioner(s) is/are previous convict or not?*

*(3) List before this Court on 11.09.2023 for further consideration.*

*(4) Meanwhile, learned State Counsel shall also get the instructions in the matter as to whether the State has any objection?*

*(5) Copy of this order be sent to learned Judicial Officer concerned forthwith for information and strict compliance."*

(4) In terms of aforesaid order, the statements of both the parties were recorded by learned Sub Divisional Judicial Magistrate, Samana and

submitted a report dated 31.08.2023. The operative part of the same reads as under:-

*“After going through the statements made by complainant/aggrieved person Mithu Ram and accused persons namely Amrik Singh, Bikramjeet Singh and Vikramjit Singh @ Vicky Gill and by investigating officer ASI Balwinder Kumar, the following report as desired by the Hon'ble High Court is submitted:*

*1) Compromise between the parties is genuine and it is voluntarily effected between the parties with their free will and without any pressure, threat, coercion or undue influence from any quarter;*

*2) Except the above said complainant and accused persons, there is one another accused namely Kapil Devi Sharma, resident of Fatehpur Tanda Road, Jalandhar, now resident of America, who is not party to the compromise;*

*3) Parties are not involved in any other case;*

*4) None of the parties have been declared as proclaimed offender;*

*5) None of the petitioners is previous convict.”*

(5) A perusal of the aforesaid report clearly reveals that matter has been compromised by both sides i.e. petitioners as well as respondent No.2 with their free consent, voluntarily and without any coercion or undue influence. Even before this Court also, there is no grievance shown by either of the parties against each other.

(6) Learned State Counsel, on instructions from ASI Paramjeet Singh, also submitted that they have no objection in case the aforesaid FIR as well as consequential proceedings are quashed on the basis of the compromise effected between the parties.

(7) Learned Counsel for respondent No.2 also raises no objection.

(8) Hon'ble the Supreme Court in '**Gian Singh Versus State of Punjab**', (2012) 10 SCC 303, has held as under:-

*“61. The position that emerges from the above discussion can be summarised thus : the power of the High Court in quashing a criminal proceeding or FIR or complaint in exercise of its inherent jurisdiction is distinct and different from the power given to a criminal court for compounding the offences under Section 320 of the Code. Inherent power is of wide plenitude with no statutory limitation but it has to be exercised in accord with the guideline engrafted in such power viz. : (i) to secure the ends of justice, or (ii) to prevent abuse of the process of any court. In what cases power to quash the criminal proceeding or complaint or FIR may be exercised where the offender and the victim have settled their dispute would depend on the facts and circumstances of each case and no category can be prescribed. However, before exercise of such power, the High Court must have due regard to the nature and gravity of the crime. Heinous and serious offences of mental depravity or offences like murder, rape, dacoity, etc. cannot be fittingly quashed even though the victim or victim's family and the offender have settled the dispute. Such offences are not private in nature and have a serious impact on society. Similarly, any compromise between the victim and the offender in relation to the offences under special statutes like the Prevention of Corruption Act or the offences committed by public servants while working in that capacity, etc.; cannot provide for any basis for quashing criminal proceedings involving such offences. But the criminal cases having overwhelmingly and predominatingly civil flavour stand on a different footing for the purposes of quashing, particularly the offences arising from commercial, financial, mercantile, civil, partnership or such like transactions or the offences arising out of matrimony relating to dowry, etc. or the family disputes where the wrong is basically private or personal in nature and the parties have resolved their entire dispute. In this category of cases, the High Court may quash the criminal proceedings if in its view, because of the compromise between the offender and the victim, the possibility of conviction is remote and bleak and continuation of the criminal case would put the accused to great oppression and prejudice and extreme injustice would be*

*caused to him by not quashing the criminal case despite full and complete settlement and compromise with the victim. In other words, the High Court must consider whether it would be unfair or contrary to the interest of justice to continue with the criminal proceeding or continuation of the criminal proceeding would tantamount to abuse of process of law despite settlement and compromise between the victim and the wrongdoer and whether to secure the ends of justice, it is appropriate that the criminal case is put to an end and if the answer to the above question(s) is in the affirmative, the High Court shall be well within its jurisdiction to quash the criminal proceeding.”*

(9) In view of above, this Court is fully convinced that the offence is entirely personal in nature and does not involve public funds. Thus, quashing of the FIR in question along with consequential proceedings on the basis of compromise would bring peace and harmony to secure the ends of justice.

(10) Consequently, present petition is allowed; aforesaid FIR along with all consequential proceedings resulting therefrom are quashed qua the petitioners. However, as a deterrence for the future, petitioners shall bear costs of ₹ 30,000/- (₹ 10,000/- each). Costs be deposited with the Punjab and Haryana High Court Bar Association, Chandigarh Lawyers’ Family Welfare Fund.

(11) Pending application(s), if any, shall also stand disposed off.
