This bunch of petitions raises a grievance against the voter list dated 18.1.2023 published by Saraswati Kunj Cooperative House Building Society, Wazirabad, Gurugram, for the election to be held on 12.2.2023.

Learned counsel appearing for official respondents on instructions from Mr. Vijender Singh, Legal Consultant, Registrar Cooperative Societies, Panchkula, submits that the elections have been postponed and before holding election, fresh voter list would be published.

Considering the subsequent development that took place during the pendency of petitions, cause of action for filing the petitions has been eroded.

No further directions are called for.

The petitions are disposed of.

Needless to say that the petitioners would be at liberty to avail remedy in accordance with law for redressal of the surviving grievance if any.

Since the main cases has been disposed of, pending application, if any is rendered infructuous.
