**AUGUSTINE GEORGE MASIH, J. (ORAL)**

Petitioner has approached this Court praying for a writ of *mandamus* directing the respondents to consider the claim of the petitioner, who asserts himself to be the legal heir of Rakhla Ram s/o Bundu Ram, resident of House No.118, Balmiki Basti, Sector-12, Karnal, where he was found to be an encroacher and on the said basis, was an applicant for allotment of a Flat in Sector-14, Part-II, Karnal, in Ashiyana Scheme. Notice was also issued to the father of the petitioner vide memo No.3210 dated 03.05.2017 but prior thereto he unfortunately expired on 10.04.2017, because of which no response thereto could be taken. Unfortunately his mother i.e., Smt. Surji Devi wife of Rakhla Ram also expired on 10.10.2017. When the petitioner came to know about the said notice having been issued as referred to above, he had approached the respondents and had been seeking the allotment of the flat. Representation dated 10.11.2022 (Annexure P-9) has also been submitted to the Chief Administrator, Haryana Sehri Vikas Pradhikaran, Sector-6, Panchkula and the Estate Officer, Haryana Sehri Vikas

Pradhikaran, Sector-12, Karnal, respondents No.1 and 2, respectively, but without any decision thereon.

Counsel for the petitioner contends that the petitioner, at this stage, would be satisfied if a direction is issued to the respondents to consider the representation of the petitioner referred to above and take a decision thereon within some specified time.

Notice of motion.

On asking of the Court, Mr. Pravindra S. Chauhan, Advocate, accepts notice on behalf of respondents.

Without going into the merits of the case or commenting thereon, we dispose of the writ petition with directions to the Chief Administrator Haryana Sehri Vikas Pradhikaran, Sector-6, Panchkula and the Estate Officer, Haryana Sehri Vikas Pradhikaran, Sector-12, Karnal, respondents No.1 and 2, to consider and decide the representation of the petitioner dated 10.11.2022 (Annexure P-9) within a period of eight weeks from today. The decision so taken be conveyed to the petitioner forthwith.
