Learned counsel for the applicant-petitioners submits that
subsequent to the passing of the orders under review, certain petitions have

been disposed of by this Court and prayer of the applicants-petitioners is that the same benefit be also extended to the applicants-petitioners hence, the orders under review may kindly be recalled and writ petitions be disposed of in terms of the order passed by this Court in **CWP-2188-2019 titled as Sukhwinder Kumar and others vs.State of Haryana and others decided on 29.08.2023.**

Learned State counsel raises no objection to the said prayer of the learned counsel for the applicants-petitioners.

Keeping in view the agreement between the parties, orders under review are recalled and the respective writ petitions are restored to its original numbers and status and are taken up for hearing today itself.

Main Cases

1. Learned counsel for the petitioner(s) submits that though, in these petitions, challenge is to the eligibility being granted to the ineligible candidates, who are competing under the category of eligible Sports Person but as there are large number of advertised posts, which are lying vacant against which the petitioner's claim can be considered, the petitioners will be satisfied in case appropriate direction is given to the respondents-State to consider the claim of the petitioners, who have already participated in the selection process and have cleared the same and they can be adjusted against the posts lying vacant, keeping in view the merit obtained by them.

2. Learned State counsel submits that in case, any grievance is raised by the petitioners before the Authorities concerned by filing any representation, the same will be considered with open mind and appropriate speaking order will be passed within a period of eight weeks from the receipt

of any such representation and in case after the decision of the representation, any benefit accrues to the petitioners, the same shall be extended to them within a period of further four weeks.

3. Keeping in view the statement made by learned State counsel, learned counsel for the petitioners submits that the present petitions may be disposed of as having been not pressed any further with liberty to the petitioners to file representation with the competent Authority.

4. Ordered accordingly.

5. Civil miscellaneous application pending, if any is also disposed of.
