Prayer in the instant petition filed under Article 226 of the Constitution of India, is for issuance of directions to respondents No.1 to 3, to provide protection of lives and liberty of the petitioners, who have married against the wishes of private respondents.

2. Learned counsel for the petitioners has brought to the notice of the Court that inadvertently, in the representation (Annexure P-6), the date has been wrongly typed as 10.02.2023 instead of 09.02.2023. The said representation was sent on 09.02.2023 itself through registered post. Learned counsel for the petitioners submits that petitioner No.1 – Parerna Rani, aged 21 years and petitioner No.2 – Rakesh Kumar aged 22 years, have solemnized marriage on 08.02.2023 against the wishes of their family members, arrayed as respondents No.4 to 7. Learned counsel for the petitioners further submits that it is the first marriage of both the petitioners. It has been submitted that the private respondents are threatening to interfere in the matrimonial life of the petitioners. Hence, the petitioners are seeking protection in that regard

and have approached this Court by way of filing the instant petition. They have also submitted a representation dated 09/10.02.2023 (Annexure P-6), to respondent No.2 – Senior Superintendent of Police, Mansa, wherein, they have expressed their apprehension.

3. Notice of motion.
4. On asking of the Court, Mr. G.S. Dhillon, AAG, Punjab, accepts notice on behalf of respondents No.1 to 3 (State).
5. In view of the above, the present petition is disposed of with a direction to respondent No.2 – Senior Superintendent of Police, Mansa, to look into the representation dated 09/10.02.2023 (Annexure P-6), *qua* threat perception, and if there is any substance in it, take necessary steps, in accordance with law, to ensure that the lives and liberty of the petitioners are not jeopardized at the hands of the private respondents.
6. However, this direction will not validate the marriage said to have taken place between the parties and will have no effect on any civil or criminal action, which could be initiated in the matter in accordance with law.
