This application is for placing on record zimni orders dated 11.11.2021, 30.11.2021, 14.12.2021, 04.01.2022, 21.09.2022, 27.10.2022, 22.12.2022 and 06.01.2023 as Annexures P-9 to P-16 respectively.

The application is allowed. Zimni orders are taken on record as Annexures P-9 to P-16.

Main case

This petition is for grant of pre-arrest bail in case FIR No. 84 dated 03.06.2019, under Section 376 IPC (Section 450 of IPC added later on), registered at Police Station Gate Hakima, District Police Commissionerate, Amritsar.

2. It is apparent on record that the petitioner was granted concession of pre-arrest bail by this Court vide order dated 11.12.2019 (Annexure P-3). Offence under Section 450 IPC was also added against him in terms of the general diary report dated 24.02.2020 (Annexure P-4). The

challan was presented on 07.04.2021, ever after the petitioner did not appear before the trial Court. On 11.11.2021,ailable warrants were issued against him for 30.11.2021, still he failed to appear. Thereupon, non-ailable warrants were issued vide order dated 14.12.2021 (Annexure P-11). The short orders have been placed on record as Annexures P-12 to P-16, which establish that the petitioner has been evading arrest and despite non-ailable warrants having been issued on 14.12.2021, 04.01.2022, 21.09.2022, 27.10.2022, 22.12.2022 and 06.01.2023, he has not been arrested.

3. In these circumstances, there is no ground to entertain this second petition for grant of pre-arrest bail to the petitioner.
4. Dismissed.
5. Pending miscellaneous application(s), if any, stand disposed of, as having been rendered infructuous.
