Learned counsel for the petitioners very fairly submits that keeping in view the fact that the petitioners were recruited through private outsourcing agency and nothing has come on record that the department had given any appointment to the petitioners coupled with the settled principle of law settled by this Court in **CWP-12274-2020 titled as Kumar Saurabh and others vs. State of Haryana and others decided on 30.09.2020**, according to which, an employee, who has been recruited through a private contractor is not entitled to file a writ petition for the relief which has been sought against the contractor, the present petitions may kindly be disposed of having been not pressed any further with liberty to the petitioners to avail an appropriate remedy before the Civil Court.
