State has filed reply dated 29.04.2021 by way of affidavit of Gurmail Singh, HPS, DSP, Pehowa, Kurukshetra. The same is taken on record. Wherein, it is specifically mentioned that in compliance with the orders passed by this Court, the respondent No.4 had been again medically examined by the Board of Doctors at LNJP, District Hospital, Kurukshetra vide MLR No. MN/06/2021/KKR dated 02.04.2021. Relevant Para 4 of the reply dated 29.04.2021 is reproduced here as under:-

*“4. That as per order passed by this Hon’ble Court the respondent no.4 again medically examined by the Board of Doctors of LNJP Hospital Kurukshetra vide MLR no. MN/06/2021/KKR daed 02.04.2021. The MRI of respondent No.4 was also conducted by the doctors of Manipal Health Map Regional Diagnostic Centre, LNJP Civil Hospital Kurukshetra as per advice of board of doctors. The relevant part of opinion of boards of doctors of LNJP Hospital Kurukshetra regarding injuries of respondent no.4 is*

*reproduced as under for kind perusal of this Hon'ble Court.*

*“Opinion of Board of Doctors at LNJP District Hospital, Kurukshetra on application moved by police dated 06.04.2021.*

*After going through medico-legal report (MLR) No.MN/06/2021/KKR dated 02.04.2021 and MRI report from Manipal Health Map Diagnostics Private Limited, report no. (Hospital No. HPAN00090562) dated 05.04.2021, we are of the opinion that nature of injury for injury no.2 mentioned in MLR no. MN/06/2021/KKR dated 02.04.2021 is Grievous in Nature”.*

2. In view of the above factual position, learned counsel for the petitioner has prayed for dismissal of petition having been rendered infructuous.

3. Ordered accordingly.
