This is a Civil Writ Petition filed under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of mandamus directing the official respondents to strictly implement the Notification dated 01.03.2021 (Annexure P-1) and letter/instructions dated 12.05.2021 (Annexure P-2) issued by respondent No.4.

Learned counsel for the petitioner has submitted that for the grievances raised by the petitioner, the petitioner has made representation dated 03.02.2023 (Annexure P-13) to respondent No.5-District Education Officer, Sirsa, in which, the averments have been made with respect to Genius School, Rania, Haryana.

Learned counsel for the petitioner has further submitted that the petitioner would not press his representation with respect to other schools

inasmuch as neither any name of any other school has been mentioned, nor any averments qua them have been made and has stated that the petitioner would be satisfied in case, respondent No.5-District Education Officer, Sirsa is directed to look into the representation dated 03.02.2023 (Annexure P-13) only qua Genius School Rania and take appropriate action, in accordance with law.

On the other hand, learned State Counsel appearing on behalf of respondent Nos.1, 4 to 6 has submitted that respondent No.5-District Education Officer, Sirsa may be directed to look into representation dated 03.02.2023 (Annexure P-13) qua averments made against Genius School, Rania but has submitted that the said directions should not be construed as an expression of opinion on the merits of the case.

Keeping in view the abovesaid facts and circumstances, the present Civil Writ Petition is disposed of with direction to respondent No.5-District Education Officer, Sirsa to look into representation dated 03.02.2023 (Annexure P-13) only qua Genius School, Rania and after considering the same, in case, any action is required to be taken, then, the same be taken, in accordance with law.

It is made clear that this Court has not opined on the merits of the case of the petitioner and respondent No.5-District Education Officer, Sirsa would consider the representation independently, in accordance with law.
