**1. By this order, I shall dispose of CRM-M-11561-2022 and CRM-M-**

**11574-2022.**

2. Petitioners – Mohinder Singh and others have brought **CRM-M-11561-2022**, under Section 482 Cr.P.C. for quashing of cross version registered vide G.D. No.25 dated 25.11.2021, under Sections 323, 324, 452, 380, 427, 506, 148, 149 IPC and under Sections 325 and 326 IPC (added later on), Annexure P2 in case FIR No.91 dated 23.10.2021 under Sections 323, 324, 506, 148 and 149 IPC registered at Police Station Bhindi Saidan, District Amritsar Rural, Annexure P1 along with all the subsequent proceedings arising therefrom on the basis of compromise deed dated 07.03.2022, Annexure P4, arrived at between the parties.

3. Whereas Petitioners – Sucha Singh and others have brought **CRM-M-11574-2022** under Section 482 Cr.P.C. for quashing of FIR No.91 dated 23.10.2021 under Sections 323, 324, 506, 148 and 149 IPC registered at Police Station Bhindi Saidan, District Amritsar Rural, Annexure P1 along with all the subsequent proceedings arising therefrom on the basis of compromise deed dated 07.03.2022, Annexure P2, arrived at between the parties.

4. Upon instructions from ASI Ranjit Singh, State counsel submits that Major Singh and Sukha Singh are injured in CRM-M-11561-2022 and Salwinder Singh son of Jagir Singh is injured in CRM-M-11574-2022, who have neither been impleaded as parties in the said petitions nor have they appeared before the Judicial Magistrate for recording of their statements in support of the compromise.

5. In view of the above, counsel for the petitioners seek and are granted permission to withdraw the petitions with liberty to approach this Court again on the basis of a fresh settlement, if arrived at between the parties.
