Petitioners have approached this Court with the grievances that despite the allotment of plot under the outsees quota to Sh. Sadhu Singh, husband of petitioner No.1 and father of petitioners No.2 to 4, the said plot No.383, Sector 2, MDC, Panchkula measuirng 500 sq. yards has not been allotted.

It is contended that the formalities with regard to the allotment of letter of intent had been completed by the father, who unfortunately expired on 27.07.2020 leaving behind the petitioners as legal heirs. The petitioners have even submitted their legal heir certificate and have also made a request for transfer of the plot in their name but till date no decision thereon has been taken.

Petitioner No.4 Ajitpal Singh, has submitted a representation dated 30.05.2022 (Annexure P-9) to the Chief Administrator, HSVP,

Panchkula and the Estate Officer, HSVP, Panchkula, but till date no decision thereon has been taken. Nor any decision conveyed to the petitioners.

Learned counsel for the petitioners contends that the petitioners, at this stage, would be satisfied if a direction is issued to the Chief Administrator, HSVP,-Panchkula as well as the Estate Officer, HSVP, Panchkula-respondents No. 1 and 2, to consider and decide the same within some specified time.

Notice of motion.

On asking of the Court, Mr. Pravindra S. Chauhan, Sr. Addl. AG Haryana, accepts notice on behalf of respondents-State.

Keeping in view the prayer made by learned counsel for the petitioners, we ***dispose of*** the present writ petition by directing the respondents No.1 and 2 to consider and decide the representation dated 30.05.2022 (Annexure P-9) within a period of ***six weeks*** from today.

Decision so taken be conveyed to the petitioners forthwith.

In case, the application/representation is accepted, the consequential benefits on completion of formalities, if any, required to be carried out by the petitioners, will be granted/released within a period of ***four weeks*** thereof.
