Learned counsel for the parties submit that both the parties have threat perception to their life and liberty from each other and further apprehended threat that one or the other party will try to take forcible possession of the property, which is in their possession and that too against the judicial verdict.

Keeping in view the fact that the parties are apprehending threat from each other, the matter can only be resolved by giving liberty that in case, any of the party apprehend any threat perception to their life and liberty or to their property of forcible dispossession, they will be at liberty to file an appropriate representation to the Senior Superintendent of Police of the concerned district for the redressal of their grievance.

Learned State counsel submits that in case any such representation is filed by either of the party, due consideration will be given to the prayer made therein and after due enquiry into the allegations, an appropriate order will be passed on the said representation and after passing of the order in case, any action is needed to be taken, the same will also be taken without any delay.

Learned counsel for the respective parties submit that keeping in view the statement made by learned State counsel, both the petitions may kindly be disposed of having been not pressed any further at this stage.

Ordered accordingly.
