The instant petition has been filed by the petitioner under Section 482 Cr.P.C. for issuance of directions to respondents No.2 and 3 to provide appropriate security to the petitioner.

On issuance of notice of motion, the learned State counsel has filed short reply by way of an affidavit of Sh. Mangal Singh, PPS, Deputy Superintendent of Police, Dinanagar, District Gurdaspur, on behalf of respondents No.1 to 4-State and the same is already on record and paras 11 & 12 of the same reads as under:-

“11. That it is humble submitted that the petitioner had filed an application dated 06.09.2019 to the office of the respondent No.3 (SSP/Gurdaspur) against Rakesh Keshi, Sunny resident of Village Ghot Pokhar, Tehsil and District Gurdaspur, Prince resident of Village Gunnopur and Meeta resident of Village Bhatian regarding threatened to kill him. The matter was got enquired by SHO Police Station Purana Shalla and he has submitted his report dated 22.01.2020 that the allegations of the petitioner the offence under Section 506 IPC was made. Hence, the DDR was registered vide G.D. No.34 dated 07.09.2019. It is further submitted that the ADGP/Security (respondent No.2) send a letter to the respondent No.3 (SSP/Gurdaspur) vide No.7653/DDSB-5 dated 26.02.2020 regarding assessment of threat perception to the petitioner. After the verification of SHO Purana Shalla, the report was sent to the respondent No.2 (ADGP/Security) vide letter No. 11470/Sec. Dated 21.03.2020 that one security person was provided to the petitioner. It is also submitted that the ADGP/Security (Respondent No.2) sent a letter to the respondent No.3 (SSP/Gurdaspur) vide No.34587/DDSB dated 15.11.2021 regarding averments made in the petition and any present threat to the petitioner from any specific quarter. The matter got enquired by SHO Police Station Purana Shalla. During the verification, ASI Jagdish Singh of Police Station Purana Shalla got recorded the statement

of the petitioner on 26.11.2021. He stated that since six months, threat call by the unknown person through phone, but after the threat calls by the unknown persons, no present call by the unknown persons. The report was sent to the ADGP/Security vide No.44103/Sec. Dated 02.12.2021 that at present no fresh threat to the petitioner by any persons. Hence, at present no security has been provided to the petitioner.
12. That it is humbly submitted that however, the directions have been issued to SHO Police Station Purana Shalla to protect the life and liberty of the petitioner.”

Since as on date there is no threat to the petitioner from any person and further that directions have been issued to SHO Police Station Purana Shalla to protect the life and liberty of the petitioner, no further orders are required to be passed in the present petition.

The present petition is disposed off accordingly.
