This is an application that has been filed for preponement of the main case which is listed for 10.07.2023.

For the reasons mentioned in the application, the same is allowed. Hearing in the writ petition is preponed and the same is taken up for hearing today itself.

CM-5581-CWP-2023

This is an application that has been filed seeking to implead Cooperative Marketing-cum-Processing Societies Limited, Jind as respondent No.5 to the petition.

For the reasons mentioned in the application, the same is allowed. Cooperative Marketing-cum-Processing Societies Limited, Jind,

District Jind, Haryana, through its Assistant Registrar is impleaded as respondent No.5 to the writ petition.

Amended memo of parties filed, is taken on record.

CWP-6152-2023

The petitioner herein seeks directions to the respondents to continue him on the post of Peon till regular appointments are made.

It is contended that the respondents have appointed other persons on the same post without there being regular appointment.

Counsel appearing on behalf of the petitioner would submit that for redressal of his grievance, the petitioner has approached the respondent department number of times by way of applications, representations and even served a legal notice, but his request was not acceded to. Counsel submits that at this stage, the petitioner would be satisfied in case his legal notice dated 01.08.2022 Annexure P-7 is decided in a time bound manner, in accordance with law.

Notice of motion.

At this stage, Mr. Anant Kataria, DAG, Haryana, who is present in Court, accepts notice on behalf of respondents.

Let adequate number of copies of the writ petition be furnished to the counsel appearing on behalf of the respondents during the course of the day.

Without commenting on merits of the case and keeping in view the limited prayer made by counsel for the petitioner, the present petition is disposed of with a direction to the respondents to decide legal notice dated 01.08.2022 Annexure P-7 within a period of two months from the date of

receipt of certified copy of this order, in accordance with law and convey the decision to the petitioner. In case of failure to do so, the officer responsible for the lapse would be liable to costs of Rs.20,000/- from his personal pocket, to be deposited with the Punjab and Haryana High Court Advocates Welfare Fund.
