1. By way of present petitions, the petitioners pray for pre-arrest bail in FIR No.21 dated 10.03.2023, registered for the offences punishable under Sections 452, 323, 325, 427, 506 and 34 of IPC (Section 379-B of IPC added later on), at Police Station Dhakoli, District SAS Nagar (Mohali).

2. As per the allegations levelled in the FIR, it has been alleged as under:-

“Copy of statement; Statement of Santosh Sharma wife of Tarun Sharma resident of Flat No. 302, Balaji Tower, Village Kisanpur Police station Dhakoli District SAS Nagar stated that I am resident of the aforementioned and I am house wife. On 03.03.2023 my husband Tarun Sharma had gone to Sri Nagar due to some work. On 06.03.2023 my son Piush Sharma was not at home then at about 1.30 pm Harwinder Singh @ Shanky son of Avtar Singh resident of House No. 416 Second Floor Dashmesh Enclave Dhakoli who use to give newspaper in our house and has come to house to take money of the newspaper then I told Harwinder Singh @ Shanky that my husband has gone out of station due to some work but Harwinder Singh @ shanky asked me that he will take money of the newspaper today itself on which I told him that we are not aware about the newspaper bill/money and my husband has the knowledge. When I said so Harwinder Singh shenky got aggressive and started abusing me and my son Piyush and he started saying me and my son Piyush that I will told how to maintain account for money. He called someone to come and we closed our flat from inside. Thereafter at about 2.10 pm the door was being knocked very loudly and few persons were talking that let them open the door once. They broke the door of second room with stones and brickbats and entered in the room in which I and my son Piyush were present and Harwinder singh @ Shanky son of Avtar Singh and his brother Ravinder Singh and Mother

Amarjeet Kaur resident of House No. 416, Second Floor Dashmesh Enclave Dhakoli and one unknown person entered in the room. They abused us my son begged pardon from them with folded hands but they did not listen us then Harwinder Singh shenky and Amarjeet Kaur caught hold me and started beating me and Amarjeet Kaur hit me with some sharp thing at my backside and my son was put down by the unknown person and Ravinder singh took out Kadda from the pocket of his pent and hit with the same on the upper side of both eyes of my son and gave injury on both shoulders and gave injury on the wrist of left arm and also hit with Kada on the back side of the head due to which my son bled badly then we raised the alarm of Marta Marta then Harwinder Singh Shenky and Ravinder Singh and Amarjeet Kaur and the unknown person ran away from the spot with their respective weapons by threatening me and my son to kill us. Then on hearing our noise our neighbor Vikas Goyal son of late Sh. Vinod Goyal Resident of Flat No. 601 Block A Blaji Tower came at the spot who took my son Piyush in his white car Verna at Civil Hospital Dhakoli where Ahamrjeet Kaur and her sons were standing at the gate and they again threatened us to kill therefore we came to Kureshian Hospital Shri Bala Ji Complex Dhakoli and got admitted there then I and my son were discharged by the doctor and we were advised bed rest. The incident of giving injuries to me and my son Piyush by Harwinder Singh @ Shanky etc. has been recorded in the cctv camera. Legal action be taken against Harwinder Singh Shanky, Ravinder Singh, Amarjeet Kaur and unknown persons. The

statement given to you and the same is correct. Sd/-
Santosh Sharma.”

- 3. Keeping in view the allegations levelled against the petitioners and the role assigned to each of them, it is not a case for grant of extra ordinary relief of pre-arrest bail.
- 4. Resultantly, the present petitions are dismissed.
