Prayer in this petition filed under Section 482 Cr.P.C. is for quashing of F.I.R. No.28, dated 09.03.2022, registered under Sections 323, 324, 341, 148 and 149 of the Indian Penal Code at Police Station Behram, District Shaheed Bhagat Singh Nagar and all subsequent proceedings arising therefrom qua the petitioners on the basis of compromise dated 27.03.2023 (Annexure P-2).

In compliance of the order dated 13.04.2023, report from learned Judicial Magistrate Ist Class, Shaheed Bhagat Singh Nagar, regarding recording of the statements of the parties have been received. As per the report statement of petitioner No.1 has not been recorded as he has not appeared before the trial court but the statement of petitioner No.2 and complainant has been recorded to the effect that the compromise has been effected between the parties voluntarily and without any coercion and pressure.

with regard to compromise before learned Magistrate on 25.04.2023.

Learned State counsel as well as learned counsel for respondent No.2 have not disputed the factum of compromise between the parties.

In view of the above, no useful purpose would be served to continue with the proceedings before the trial Court in the instant complaint following the principles laid down by the Full Bench judgment of this Court in *Kulwinder Singh and others Versus State of Punjab and another 2007 (3) RCR (Criminal) 1052* and approved by the Hon'ble Supreme Court in *Gian Singh Versus State of Punjab and others (2012) 10 SCC 303*, this petition is allowed and F.I.R. No.28, dated 09.03.2022, registered under Sections 323, 324, 341, 148 and 149 of the Indian Penal Code at Police Station Behram, District Shaheed Bhagat Singh Nagar (Annexure P-1) along with all the subsequent proceedings arising therefrom on the basis of compromise dated 27.03.2023 (Annexure P-2) effected with complainant-respondent No.2 Jaskaran Singh, are hereby quashed qua the petitioners.
