1. The petitioner has filed the present petition under Section 438 Cr.P.C. with a prayer to grant anticipatory bail to him in case FIR No.119 dated 04.04.2021, registered under Sections 323, 452, 506, 148, 149 of IPC and Section 379-B of IPC added later on, at Police Station Sohana, District SAS Nagar, Mohali.

2. Learned counsel for the petitioner submits that in compliance of the order dated 28.05.2021 passed by a Co-ordinate Bench of this Court, the petitioner has joined the investigation.

3. Learned counsel for the State has submitted that the petitioner has joined the investigation and is no longer required for further investigation.

4. In view of the statement made by learned State counsel, the present petition is allowed and the interim order dated 28.05.2021 passed by a Co-

ordinate Bench of this Court, is made absolute. The petitioner shall continue to join investigation, as and when called by the Investigating Officer and shall also abide by the conditions as provided under Section 438(2) of the Cr.P.C. alongwith the following other conditions:-

- (i) *The petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case, so as to dissuade him to disclose such facts to the Court or to any other authority.*
- (ii) *The petitioner shall surrender his passport, if any, (if already not surrendered), and in case he is not holder of the same, he shall swear an affidavit to that effect.*
- (iii) *The petitioner shall also file his affidavit before the concerned I.O./Arresting Officer, mentioning his ordinary place of residence and number of mobile phone, which shall be used by him during the pendency of the case. In case of change of place of residence/mobile number, he shall share the details with the concerned Investigating Officer.*
- (iv) *In case, the petitioner involves in any other criminal activity, during the pendency of the case, it shall be viewed seriously and the prosecution shall be at liberty to move a petition for cancellation of bail granted to him.*

5. Pending application, if any, is also disposed of.
