By this common order, I propose to dispose of following two petitions:-

(I) CRM-M-32736-2016 (O&M)

This petition under Section 482 Cr.P.C. has been filed for quashing of FIR No. 19 dated 14.02.2013 under Sections 364-A IPC registered at Police Station City Kharar, District SAS Nagar and all consequential proceedings arising there from.

(ii) CRM-M-8705-2016 (O&M)

This petition under Section 482 Cr.P.C. has been filed for directing the official respondents to take necessary action to conduct Narco-analysis test of respondent No. 7 as well as petitioner No. 2 as has been directed by Hon'ble High Court vide order dated 16.01.2015 and 15.09.2015 (Annexures P-4 and P-5). Petitioner also prayed for conducting a speedy, effective and fair enquiry/investigation in a case FIR No. 19 dated 14.02.2013 under Sections 364-A IPC registered at Police Station City Kharar, District SAS Nagar.

Today learned State counsel on instructions from ASI Kulwinder Singh, submits that in FIR No. 19 dated 14.02.2013 under Sections 364-A IPC registered at Police Station City Kharar, District SAS Nagar, cancellation report has been prepared and same is likely to be submitted in near future.

In view of the stand taken by learned State counsel, counsel for the petitioners seeks withdrawal of both the petitions i.e. CRM-M-32736-2016 and CRM-M-8705-2016, at this stage.

Dismissed as withdrawn, at this stage.
