HARSIMRAN SINGH SETHI, J. (ORAL)

1. By this common order, the bunch of writ petitions, the details of which have been given in the heading, are being decided as all the petitions involve the same question of law on similar facts.

2. Learned counsel appearing on behalf of the petitioners in writ petitions mentioned from Serial No. 1 to 37 submits that keeping in view the reply filed by the respondents that the petitioners have been kept out of the purview of the policy dated 30.06.2022, the grievance of the petitioner stands redressed and no further order is required to be passed and the same may kindly be disposed of as not pressed any further.

3. Ordered accordingly.

4. Learned counsel appearing on behalf of the petitioners in petitions No. 38 to 71 submits that as per the reply, the respondents have stated that no decision qua the petitioners in the said petitions have been taken due to non-availability of sufficient/actual facts. Learned counsel for the petitioners further submits that the petitioners will file appropriate representation bringing to the notice of the department that they are also entitled for being excluded from the purview of the policy dated 30.06.2022 as being done in the cases of other petitioners.

5. Learned State counsel submits that in case, any representation is filed by the petitioners, the same will be disposed of in accordance with law by keeping

in view of the provisions of the policy dated 30.06.2022 and considering the claim of each and every petitioner by passing appropriate speaking order within a period of 4 weeks from the receipt of the any such representation and in case, after the decision of the representation, any of the petitioners is found entitled for any relief, the same will also be extended to them within a further period of 2 weeks.

6. Learned counsel for the petitioners, details of which petitions have been given in the heading of the order starting from Sr. No. 38 to 71, submits that these petitions be disposed of as not pressed any further with liberty to the petitioners to file appropriate representation.

7. Ordered accordingly.

8. Any civil miscellaneous application pending if any, also stands disposed of.
