Prayer in this petition filed under Section 482 Cr.P.C. is for quashing of F.I.R. No.48, dated 28.02.2023, registered under Sections 148, 149, 323 and 506 of the Indian Penal Code at Police Station Shahzadpur, District Ambala and all subsequent proceedings arising therefrom qua the petitioners on the basis of compromise dated 01.04.2023 (Annexure P-2).

In compliance of the order dated 20.04.2023, report dated 15.05.2023 from learned Judicial Magistrate Ist Class, Naraingarh, regarding recording of the statements of the parties have been received. Both the petitioners as well as complainants-respondent Nos.2 to 4 had made statement regarding the compromise to the effect that the compromise has been effected between the parties with their sweet will and without any coercion or undue influence.

Respondents No.2 to 4, namely Rishi Raj, Brijpal and

Mandeep Singh had made their statement with regard to compromise before learned Magistrate on 12.05.2023.

Learned State counsel as well as learned counsel for respondents No.2 to 4 have not disputed the factum of compromise between the parties.

In view of the above, no useful purpose would be served to continue with the proceedings before the trial Court in the instant complaint following the principles laid down by the Full Bench judgment of this Court in *Kulwinder Singh and others Versus State of Punjab and another 2007 (3) RCR (Criminal) 1052* and approved by the Hon'ble Supreme Court in *Gian Singh Versus State of Punjab and others (2012) 10 SCC 303*, this petition is allowed and FIR No.48, dated 28.02.2023, registered at Police Station Shahzadpur, District Amabala, uder Sections 148, 149, 323 and 506 of IPC (Annexure P-1) along with all the subsequent proceedings arising therefrom on the basis of compromise dated 01.04.2023 (Annexure P-2) effected with complainant-respondents No.2 to 4 Rishi Raj, Brijpal and Mandeep Singh, are hereby quashed qua the petitioners.
